### **Payment Schedule**

New Students: The building fee, at least one semester's tuition, and the host family fee (if applicable) are due upon receipt of the student's letter of acceptance. Second (spring) semester's tuition is due December 1.

Returning Students: Tuition and the host family fee (if applicable) must be paid prior to each semester - July 1 for fall (August) semester and December 1 for spring (January) semester.

When arranging a wire transfer, please note the student's name on the transfer information and request that the receiving bank fax notice of wire to Gilbert Christian Schools at (480) 809-6688. We will gladly confirm thereceipt of funds.

Application Fee: The application fee covers the cost of the application, document preparation, and mailing of acceptance documents. The fee is non-refundable, even if the student is unable to obtain the appropriate visa. The deadline to apply for August admission (fall semester) is May 1. The deadline to apply for January admission (spring semester) is November 1. (Students may only transfer for the spring semester if they are currently enrolled in a U.S. high school.)

Building Fee: The building fee is a mandatory, one-time fee charged to every new family to cover the cost of maintaining the campus. This fee (along with at least one semester's tuition and the host family fee, if applicable) is due upon receipt of the student's letter of acceptance and must be paid before an I-20 is issued.

<u>Tuition</u>: Tuition fees include all classes, placement tests, textbooks, standardized achievement tests, and class supplies. Also included in your tuition payment are a yearbook, winter homecoming ticket, and spring formal ticket. Tuition must be paid before the student is allowed to enter classes for that semester. Once the student has entered classes, the tuition for that semester is non-refundable because it has been committed to teachers and supplies. Tuition refunds will be made for school semesters paid for but not yet begun. Fines willbe assessed for lost or damaged textbooks. Tuition does not include lunches and other optional events.

<u>Host Family Fee</u>: The host family fee is an annual fee that covers the cost of utilities, food (prepared by the host family), and daily transportation to and from school. All other costs (including clothing, holiday travel within the United States, travel to the student's home country, cell phone usage, expenses for participation insports activities, hot school lunches, etc.) are the sole responsibility of the student.

<u>Medical Coverage</u>: Major medical insurance is included in the price of tuition. Medical care in the U.S. is expensive. All non-immigrant students must demonstrate their ability to pay all debts that they incur while inthis country. Therefore, students are required to have major medical insurance coverage while they are enrolled at Gilbert Christian Schools. (Dental and vision care are <u>not</u> covered.)
