

EVIT- Power Campus Partnership Requirements

Students who desire to attend and graduate from GCHS would have the ability to utilize East Valley Institute of Technology (**EVIT- Power Campus Programs only**) provided they can meet the requirements below. EVIT- Power Campus is a publicly funded educational system of career training options for students in the east valley. This program will be available for students in their junior and/or senior year only. Students participating in the EVIT- Power Campus program are not eligible for consideration of GCHS valedictorian and salutatorian.

Students will be required to:

- Attend GCHS for the first four periods of the day taking all required core subjects for graduation at GCHS
 - 11th Grade core courses: Bible 11, Math, Science, English
 - 12th Grade core courses: Bible 12, Math, English, Govt/Econ
- Take US History outside of the normal school day before end of Junior Year at the family's expense
- All courses must fit their schedule based on availability at GCHS
- Stay on track to graduate by passing all courses at both GCHS and EVIT-Power Campus
- Pay full tuition at GCHS (ESA recipients will need to determine EVIT-Power Campus cost of attendance)
- Students may not regularly leave GCHS classes early. Documentation is required by EVIT on the rare instance that an early dismissal is necessary.

1. EVIT schedule takes priority.

Students enrolled in EVIT follow the EVIT schedule. We understand EVIT begins at noon every day, which means that regardless of whether we are on a Chapel, Assembly, or other modified bell schedule you will still need to leave campus at the same time. This may occasionally cause you to miss part of your instructional time here at GCS.

It is **the student's responsibility** to know when it's time to leave for EVIT and to communicate that directly with their 4th-period teacher. The office will **not** be sending reminders or tracking students down on off-schedule days. Students must manage their own departure times and ensure they make up any missed work with their teacher.

2. Uniform expectations.

Students are responsible for changing into their EVIT uniform. Please note that you will not be excused from class early to change, nor should you change into your EVIT uniform while on the

GCS campus. While here, students are expected to remain in GCS dress code. Please make arrangements to change at EVIT.

3. Lunch and campus safety.

Lunch at GCS is tied directly to 5th period. Students attending lunch are accounted for through their 5th-period rosters. Since EVIT students do not take a 5th-period class, they are **not permitted to stay on campus for lunch**. This policy is in place for safety reasons; in the event of an emergency, it is critical that we know exactly who is on campus. If some EVIT students stay for lunch and others do not, it becomes difficult to account for everyone. For this reason, all EVIT students must leave campus after 4th period.

Students would be allowed to:

- Receive a diploma from GCHS and participate in the Graduation ceremony and Baccalaureate event at GCHS;
- Participate in athletics, activities, and clubs but due to potential conflicts with schedules the Vice Principal of Student Affairs will have the final decision

*GCHS cannot guarantee that students will be able to enroll in honors and dual enrollment courses.

*Students are required to follow EVIT- Power Campus's schedule for breaks (fall, winter, spring, and summer).

*Students will work closely with their GCHS counselor in order to make sure they are completing all required classes to graduate from GCHS.
